Future requests for a certificate of residence

When you ask for a certificate of residence in the future, please check the Double Taxation Relief manual. This will tell you if the foreign tax authority needs you to use a specific form when making a claim. For more information, go to www.gov.uk and search 'dt2140pp'.

When the foreign tax authority needs you to use a specific claim form, make sure that you read any guidance notes that come with it. These are usually at the end of the form.

Please make sure that you:

- use the correct claim form and check which copies are needed
- fully complete the claim form in line with the instructions
- sign the form

To avoid unnecessary delays, please check all forms before sending them to us to authorise.

The following is our latest requirement for all future requests for certificates of residence.

If the foreign tax authority does not need a specific claim form, or their specific form does not cover the following 4 points, we will need this information. Please give us this information separately, in writing, when you request certificates. If you do not, we cannot issue a certificate.

- 1 The name of the country that you need the certificate for, and the reason why it's needed.

If you need extra support, for example if you have a disability, a mental health condition, or do not speak English/Welsh, go to www.gov.uk and search for 'get help from HMRC'.

- 2 The type of income for example, business profits, dividends, interest or royalties.
- 3 Details of the accounting periods that the certificate is needed for. We do not send certificates for accounting periods that end on a future date.
- 4 Confirmation that the company
 - is the beneficial owner of the income you tell us about (this does not include an agent or nominee)
 - is the legal owner of the income, and that UK Corporation Tax will apply to all the income
